First call for strategic projects

Features of strategic projects

- contribute to the achievement of the objectives of the European strategies and the Programme objectives with a significant sustainable impact on the Programme-area, also through the identification of appropriate indicators;
- have a clear strategic value in the proposed topics for the area involved and for border areas specifically;
- have a genuine crossborder character both in terms of crossborder impact as well as of partnership;
- meet the four requirements set out by art. 19 of Regulation (EC) No 1080/2006: joint development, joint implementation, joint staffing and joint financing;
- ensure the prosecution of cooperation also after the end of the project;
- ensure visible and durable effects and results;
- be conceived and implemented by a partnership composed of partners with the appropriate level of competence with reference to the projects' topics and assuring the achievement of the outputs and results.

Area, eligible applicants, duration of projects

- Projects on all 3 priorities
- The whole Programme area (flexibility rule 20%) and all applicants foreseen in the OP per priority
- main office or a branch office or administrative jurisdiction in the eligible Programme area
- LP Principle
- Duration: 4 years (3 months more)
- Manual on eligibility of expenditure
